SECTION 1: ELIGIBILITY

Membership is open to (but not limited to) any Idaho resident, business, nonprofit, or organization that supports the mission of the Cascade Chamber of Commerce.

SECTION 2: MEMBERSHIP CLASSES

- **General Members** – Includes businesses, individuals, nonprofits, agencies, and other organizations. General Members in good standing may vote, hold office, and fully participate in Chamber activities.
 - **Associate Members** – Designed for organizations, agencies, or associations. Dues are determined by the Membership Committee and may be waived through reciprocating partnerships. Associate Members **do not have voting rights**.
 - **Sponsorship Members** – Businesses, agencies, or nonprofits that want to invest in the long-term sustainability of the Chamber. Sponsorship Members **do have voting rights** and play a key role in helping the Chamber support initiatives such as workforce development, small business education, affordable housing, rural development, and more.
