A huge thank you to them also for donating all the shirts for sale, snacks, drinks, and supplies.
  - b. Duck Race (Tom/Pam): Went well with Cascade Aquatic Center Will have more duck catchers next year if we can. The span across the river randomly and paddling back and forth for 2 folks was good and if we had more might be better. Thanks to Tom for all his support this year and to the Aquatic Center for supporting the event as well. We will donate a certain percentage of the total profit to them.
  - c. Coleman Bike (Pam): Did not do as well as the ebike has however, there was some great insights into how we could do better with it next year. We were not far off from breaking even, and we are okay with that considering how the other fundraising has gone this year. Will discuss next year what to do.
  - d. Fireworks (Mindi): We will be following up with the Companies on feedback.
  - e. Parade (Kathy/Julie): Next year we will be requiring all parade entries to have walkers that are spotters and those will be the ones required to be providing candy. We will continue to have
